Subject :- Issue of Essentiality Certificate under Rule 44 of the Delhi School Education Act, 1973.

Sir,

With reference to your application on the subject cited above, I am directed to convey the permission of the Director of Education, Delhi to your society to establish a new school from class Ist to VIII (without aid) in Dilshad-Garden Area, Zone-VIII of Distt. East, subject to the following conditions :-

1. That the provision of DSE R, 1973 and the rules framed thereunder shall be observed by the society.
2. That the management of the school will fulfil all the conditions laid down under rule 30 and will provide all the facilities given in Rule 51 of DSE R, 1973 to the institution.
3. That the management of the school will get the scheme of management approved from the department immediately.
4. That only qualified and trained teachers will be appointed at prescribed Govt. Scales alongwith all allowances will be paid to the teaching and non-teaching staff through crossed cheque. Provision of sec. 10(1) of DSEA, 73 will be fulfilled.
5. That the management of the school will not ask for grant-in-aid from the department.
6. That in case that any time the management of the school is unable to run the school moveable and non-moveable property of the school will be transferred in the name of Director of Education, Delhi.
7. That the school will not run for the profit of any individual association or group of persons.
8. That the management of the school will apply for grant-of recognition of the school under DSEA and Rules, 1973 separately and recognition will not be granted unless statutory provisions of section 4(i) (a) to (f) read with rules 50 and 51 are fulfilled.
9. That all the recognised classes shall be run at one place only.
10. That the management of the school will approach DDA for land on the basis of this EC through Directorate of Education, Delhi.
11. That the school shall be run under the control of St. Lawrence Educational Society (Regd.), Delhi and suitable funds will be made available for the constructions of suitable building.

12. That adequate and sufficient accommodation of 12 sq.ft. per student shall be provided for class-room. The normal size of class-room will be 24' X 20'. No other activities other than education shall be run.

If recognition for the proposed school is not sought after fulfilling all the above conditions within a period of 3 years, this permission to run a new school shall be treated as cancelled.
