- 8. That the management of the school will apply for grantof recognition of the school under DSEA and Rules, 1973 separately and recognition will not be granted unless statutory provisions of section 4(1) (a) to (f) read with rules 50 and 51 are fulfilled.
- 9. That all the recognised classes shall be run at one place
- That the management of the school will approach DDA for land on the basis of this EC through Directorate of ENNOPAL
- 11/ That the school small be run under the control of KSEccilly Comence St. Lawrence Public Sr. Sec. 32 Educational Society(Regd.), Dalhi and suitable funds will be 10095 made available for the constructions of suitable building

on the land allotted to the society, as declared as per the specifications of the department within a period of three days.

12. That adequate and sufficient accommodation of 12 sq.fc.

12. That adequate and sufficient accommodation of 12 sq.ft. per student shall be provided for class-room. The normal size of class-room will be 24' X 20'. No other activities other than aducation shall be run.

If recognition for the proposed school is not

saught after fulfilling all the above conditions within a period of 3 yours, this permission to run a new school shall be treated as gancelled.
